UNDERSTANDING CRIME SCENE CLEANUP

THE INITIAL CALL AND RESPONSE

THE PROCESS BEGINS WITH A CALL TO A CRIME SCENE CLEANING COMPANY, OFTEN INITIATED BY FAMILY MEMBERS, PROPERTY OWNERS, OR LAW ENFORCEMENT. THE URGENCY OF THE SITUATION DICTATES THE RESPONSE TIME, WHICH CAN VARY BASED ON THE COMPANY'S PROTOCOLS AND THE SEVERITY OF THE INCIDENT. ASSESSING THE SITUATION

EQUIPMENT AND SUPPLIES USED

ESSENTIAL CLEANING TOOLS

SOME OF THE MOST COMMONLY USED EQUIPMENT INCLUDES:

- PROTECTIVE CLOTHING (GLOVES, MASKS, SUITS)
- BIOHAZARD DISPOSAL CONTAINERS
- COMMERCIAL-GRADE DISINFECTANTS AND DEODORIZERS
- INDUSTRIAL VACUUMS AND EXTRACTORS
- STEAM CLEANERS AND PRESSURE WASHERS

THE CLEANING PROCESS
