UNDERSTANDING BRAND AND GENERIC DRUGS

ON THE OTHER HAND, GENERIC DRUGS ARE COPIES OF BRAND DRUGS THAT HAVE THE SAME ACTIVE INGREDIENTS, DOSAGE FORMS, AND STRENGTHS, BUT ARE SOLD UNDER THEIR CHEMICAL NAME OR A DIFFERENT NAME. ONCE THE PATENT ON A BRAND DRUG EXPIRES, OTHER COMPANIES CAN MANUFACTURE AND SELL THE GENERIC VERSION. THIS COMPETITION OFTEN LEADS TO LOWER PRICES FOR CONSUMERS WHILE MAINTAINING THE SAME EFFICACY.

IT'S ESSENTIAL TO UNDERSTAND THAT WHILE GENERIC DRUGS ARE CHEMICALLY IDENTICAL TO THEIR BRAND-NAME COUNTERPARTS, THERE CAN BE VARIATIONS IN INACTIVE INGREDIENTS, SUCH AS FILLERS OR COLORINGS. THESE DIFFERENCES CAN SOMETIMES AFFECT HOW THE BODY ABSORBS THE MEDICATION, BUT IN MOST CASES, GENERICS PERFORM JUST AS WELL AS BRAND-NAME DRUGS.

REGULATORY FRAMEWORK FOR DRUG APPROVAL

THE APPROVAL PROCESS FOR BRAND AND GENERIC DRUGS IS RIGOROUS AND STRICTLY REGULATED BY GOVERNMENT AGENCIES SUCH AS THE FOOD AND DRUG ADMINISTRATION (FDA) IN THE UNITED STATES. ONCE THE PATENT EXPIRES, MANUFACTURERS OF GENERIC DRUGS MUST ALSO SUBMIT AN ABBREVIATED NEW DRUG APPLICATION (ANDA) TO THE FDA. THIS APPLICATION MUST DEMONSTRATE THAT THE GENERIC DRUG IS BIOEQUIVALENT TO THE BRAND DRUG, MEANING IT DELIVERS THE SAME AMOUNT OF ACTIVE INGREDIENTS INTO THE BLOODSTREAM IN THE SAME AMOUNT OF TIME. THIS REGULATORY PATHWAY ENSURES THAT GENERICS MEET THE SAME STANDARDS OF QUALITY, STRENGTH, AND PURITY AS BRAND DRUGS.

- **BRAND DRUGS:** SUBJECT TO EXTENSIVE CLINICAL TRIALS AND PATENT PROTECTION.
- **GENERIC DRUGS:** REQUIRE PROOF OF BIOEQUIVALENCE AND CAN ENTER THE MARKET AFTER THE PATENT EXPIRES.

THE TRUTH IS THAT SIDE EFFECTS ARE PRIMARILY RELATED TO THE ACTIVE INGREDIENTS IN THE MEDICATION, NOT THE BRAND OR GENERIC LABEL. WHILE INDIVIDUAL EXPERIENCES MAY VARY, GENERICS ARE SUBJECTED TO THE SAME RIGOROUS TESTING AS BRAND DRUGS.

DEBUNKING COMMON MYTHS
