USE A MIX OF QUESTION TYPES

INCORPORATE VARIOUS QUESTION TYPES TO KEEP PARTICIPANTS ENGAGED. USE MULTIPLE-CHOICE QUESTIONS FOR QUICK ASSESSMENTS, OPEN-ENDED QUESTIONS FOR DEEPER UNDERSTANDING, AND TRUE/FALSE QUESTIONS FOR STRAIGHTFORWARD FACTS.

ENSURE CLARITY AND RELEVANCE

QUESTIONS SHOULD BE CLEAR AND CONCISE. AVOID JARGON UNLESS IT'S WIDELY RECOGNIZED IN THE FIELD. EACH QUESTION SHOULD RELATE DIRECTLY TO THE LEARNING OBJECTIVES AND THE MATERIAL COVERED.

INCORPORATE REAL-WORLD SCENARIOS

INCLUDING REAL-WORLD SCENARIOS IN YOUR QUESTIONS CAN ENHANCE ENGAGEMENT AND PROVIDE PRACTICAL CONTEXT. THIS APPROACH HELPS PARTICIPANTS APPLY THEORETICAL KNOWLEDGE TO PRACTICAL SITUATIONS, IMPROVING RETENTION.

PROVIDE FEEDBACK
