Understanding Ionic Compounds

Formation of Ionic Bonds

Electron Transfer Explained

The actual mechanism of electron transfer involves the repulsion of electrons in the outer shell of the metal atom and the attraction of electrons in the valence shell of the nonmetal atom. This transfer doesn't happen in isolation; it's often facilitated by the proximity of the atoms and the energy considerations involved. The energy released when the anion is formed (electron affinity) combined with the energy required to ionize the metal (ionization energy) and the energy released by the formation of the ionic lattice (lattice energy) all contribute to the overall stability of the ionic compound. Cation and Anion Formation

Naming Ionic Compounds

Naming Ionic Compounds with Transition Metals

Transition metals (elements in Groups 3-12) are a bit more complex because they can often form ions with different charges. When naming ionic compounds containing transition metals that can have multiple oxidation states, you must specify the charge of the cation using Roman numerals in parentheses immediately following the metal's name. For example, iron can form Fe^{2+} and Fe^{3+} ions. The compound FeCl_2 contains Fe^{2+} ions and chloride ions. Therefore, it is named iron(II) chloride. The compound FeCl_3 contains Fe^{3+} ions and chloride ions, so it is named iron(III) chloride. This Roman numeral system is essential for distinguishing between different ionic compounds of the same elements.

Naming Ionic Compounds with Polyatomic Ions

Polyatomic ions are charged ions composed of two or more atoms covalently bonded together. Examples include sulfate (SO_4^{2-}), nitrate (NO_3^-), and ammonium (NH_4^+). When naming ionic compounds that include polyatomic ions, the name of the polyatomic ion is used directly. For instance, NaNO_3 consists of sodium ions (Na^+) and nitrate ions (NO_3^-). Properties of Ionic Compounds

Brittleness
