THE GUIDELINES FOR CITING WEBSITES AND OTHER ONLINE RESOURCES HAVE BEEN CLARIFIED, OFTEN EMPHASIZING THE INCLUSION OF THE DOI (DIGITAL OBJECT IDENTIFIER) WHEN AVAILABLE, AND THE URL OTHERWISE, TO ENSURE PERSISTENT ACCESS TO SOURCES. BOTH METHODS EFFECTIVELY ATTRIBUTE SOURCES, WITH THE CHOICE OFTEN DEPENDING ON SENTENCE STRUCTURE AND EMPHASIS. FOR DIRECT QUOTATIONS, A PAGE NUMBER OR OTHER LOCATOR (E.G., PARAGRAPH NUMBER FOR ONLINE SOURCES) MUST ALSO BE INCLUDED.

## CITING MULTIPLE AUTHORS AND CORPORATE AUTHORS

AS MENTIONED, FOR WORKS WITH THREE OR MORE AUTHORS, THE APA 7TH EDITION SIMPLIFIES IN-TEXT CITATIONS BY USING ONLY THE FIRST AUTHOR'S SURNAME FOLLOWED BY "ET AL." FROM THE FIRST CITATION ONWARDS. FOR EXAMPLE, (JONES ET AL., 2021). WHEN CITING CORPORATE OR GROUP AUTHORS, THE FULL NAME OF THE ORGANIZATION IS TYPICALLY USED IN THE FIRST CITATION, WITH AN ABBREVIATION IF APPLICABLE IN SUBSEQUENT CITATIONS, PROVIDED THE ABBREVIATION IS IDENTIFIABLE AND ESTABLISHED. CONSULTING AN APA 7TH EDITION REFERENCING GUIDE PDF IS INVALUABLE FOR CLARIFYING SPECIFIC SCENARIOS AND ENSURING ACCURACY.

## DIRECT QUOTATIONS AND PARAPHRASING

WHILE IT DOES NOT REQUIRE QUOTATION MARKS, IT STILL NECESSITATES AN IN-TEXT CITATION WITH THE AUTHOR AND YEAR, AND IT IS HIGHLY RECOMMENDED TO INCLUDE A PAGE OR PARAGRAPH NUMBER TO ASSIST READERS IN LOCATING THE ORIGINAL PASSAGE.

- FOR DIRECT QUOTATIONS: INCLUDE AUTHOR, YEAR, AND PAGE NUMBER (E.G., "..." (AUTHOR, YEAR, P. X)).
- FOR PARAPHRASING: INCLUDE AUTHOR AND YEAR (E.G., (AUTHOR, YEAR)). PAGE NUMBERS ARE ENCOURAGED BUT NOT REQUIRED.
- FOR BLOCK QUOTATIONS (40+ WORDS): INDENT THE ENTIRE BLOCK 0.5 INCHES FROM THE LEFT MARGIN, DOUBLE-SPACE, AND DO NOT USE QUOTATION MARKS. THE CITATION FOLLOWS THE PUNCTUATION.

PUBLICATION, TITLE OF THE WORK, AND SOURCE INFORMATION (E.G., JOURNAL NAME, PUBLISHER, URL, DOI). PRECISION IN PUNCTUATION, CAPITALIZATION, AND ITALICIZATION IS PARAMOUNT.

## CITING LESS COMMON SOURCES

A: PAGE NUMBERS ARE ALWAYS REQUIRED FOR DIRECT QUOTATIONS TO HELP READERS LOCATE THE EXACT PASSAGE IN THE SOURCE. FOR PARAPHRASED MATERIAL, PAGE NUMBERS ARE HIGHLY RECOMMENDED BUT NOT STRICTLY REQUIRED. ## **Q: WHAT IS A DOI, AND WHY IS IT IMPORTANT IN APA 7TH EDITION REFERENCES?**

A: A DOI (DIGITAL OBJECT IDENTIFIER) IS A UNIQUE ALPHANUMERIC STRING USED TO PERMANENTLY IDENTIFY AN ONLINE ARTICLE OR OTHER INTELLECTUAL PROPERTY AND PROVIDE A PERSISTENT LINK TO ITS LOCATION ON THE INTERNET. IN APA 7TH EDITION REFERENCES, DOIs ARE CRUCIAL FOR DIGITAL SOURCES, ESPECIALLY JOURNAL ARTICLES, BECAUSE THEY OFFER A STABLE AND RELIABLE WAY FOR READERS TO ACCESS THE EXACT SOURCE, EVEN IF THE URL CHANGES OVER TIME. IF A DOI IS AVAILABLE, IT SHOULD ALWAYS BE INCLUDED IN THE REFERENCE LIST ENTRY.

## Q: WHAT IS THE SIGNIFICANCE OF USING INCLUSIVE AND BIAS-FREE LANGUAGE IN APA 7TH EDITION?
