MANUAL ADJUSTMENTS AND UNDERSTANDING THE GUIDELINES

RELYING SOLELY ON AN APA 7TH EDITION WORKS CITED GENERATOR WITHOUT ANY FOUNDATIONAL UNDERSTANDING OF THE GUIDELINES CAN LEAD TO UNDETECTED ERRORS. THERE WILL ALWAYS BE INSTANCES WHERE MANUAL ADJUSTMENTS ARE NECESSARY, OR WHERE A GENERATOR MAY INTERPRET INFORMATION DIFFERENTLY THAN INTENDED. DEVELOPING A WORKING KNOWLEDGE OF APA 7TH EDITION RULES ALLOWS USERS TO:

- SPOT ERRORS IN CAPITALIZATION (E.G., SENTENCE CASE VS. TITLE CASE).
- VERIFY THE CORRECT USE OF ITALICS FOR TITLES OF MAJOR WORKS.
- ENSURE PROPER PUNCTUATION AND SPACING WITHIN CITATIONS.
- CORRECTLY FORMAT HANGING INDENTS FOR THE REFERENCE LIST.

A: MOST APA 7TH EDITION WORKS CITED GENERATORS PRIMARILY FOCUS ON CREATING FULL BIBLIOGRAPHIC ENTRIES FOR THE REFERENCE LIST. WHILE SOME MAY OFFER TOOLS OR GUIDANCE FOR IN-TEXT CITATIONS, THEIR CORE FUNCTION IS USUALLY THE END-OF-PAPER BIBLIOGRAPHY. YOU'LL TYPICALLY NEED TO APPLY YOUR UNDERSTANDING OF APA IN-TEXT CITATION RULES (AUTHOR-DATE FORMAT) SEPARATELY.

Q: WHAT INFORMATION DO I TYPICALLY NEED TO INPUT INTO AN APA 7TH EDITION WORKS CITED GENERATOR?

A: THE INFORMATION REQUIRED VARIES BY SOURCE TYPE, BUT COMMON DATA POINTS INCLUDE AUTHOR(S) NAME(S), PUBLICATION DATE, TITLE OF THE WORK, TITLE OF THE LARGER WORK (E.G., JOURNAL TITLE, BOOK TITLE), PUBLISHER, VOLUME AND ISSUE NUMBERS (FOR JOURNALS), PAGE RANGE, AND A DOI OR URL IF APPLICABLE.
