- CHECK FOR HIGHLIGHTING OR WRITING IN THE TEXT.
- EXAMINE THE SPINE FOR CREASES OR DAMAGE.
- LOOK AT THE COVER FOR SCRATCHES, DENTS, OR FADING.

EDITION AND PUBLICATION DATE

THE EDITION OF A TEXTBOOK CAN GREATLY IMPACT ITS VALUE. NEWER EDITIONS ARE OFTEN PREFERRED BECAUSE THEY CONTAIN UPDATED INFORMATION AND CASE LAW. IF YOU HAVE AN EARLIER EDITION, RESEARCH WHETHER IT IS STILL RELEVANT OR IN DEMAND AMONG STUDENTS AND PROFESSIONALS. TYPICALLY, THE MORE RECENT THE PUBLICATION DATE, THE BETTER THE PRICE YOU CAN EXPECT.

DEMAND FOR THE TEXTBOOK
